

The following is a reprint, in part, of a pamphlet published by the New York State Bar Association in cooperation with the New York City Department for the Aging on the subject for elder New Yorkers.

13. SENIOR CITIZEN HOMEOWNERS EXEMPTION (SCHE)--

Up to 50% reduction in taxes for qualified property owners.

Age: 65 or older. If spouse or siblings are co-owners, one must be at least 65 years of age. If other persons are co-owners, all must be 65 years of age. Property must be used exclusively as legal residence.

Resources: No limit.

Income: Income limits vary by locality. In NYC-Up to \$24,000 - 50% exemption; \$24,001 to \$32,400 - 45%-5% exemption. Income is determined after deduction for unreimbursed medical and prescription drug expenses (at local governmental option).

Applicant must have held title to property for at least 12 consecutive months. The property must be used exclusively for residential purposes and have no more than three units.

Apply: to your local assessment office, available from New York State Office for Aging (800) 342-9871.

Note: The period in which to apply is limited. Please clarify with your assessor. In general, the ability to apply ends in March for the current year. Applications must be made in person. Bring deed to property, proof of income, birth and residency

14. REAL PROPERTY TAX CREDIT (IT-214) Provides tax credit or cash payment for part of rent or property taxes paid during previous year.

Age: Any age.

Resources: No limit.

Income: \$18,000 or less. (Filing a tax return for the preceding year is not a requirement.)

Homeowner's current market value of real property must be \$85,000 or less. Renter's average monthly rent must be \$450 or less, not including heat, gas, electricity, etc.

Apply: by submitting Form IT-214 with tax return, or, if no return, anytime during the year. For assistance from New York State Department of Taxation and Finance call (800) 225-5829.

15. REDUCED FARE- Substantial savings for various public and private transit services.

Age: 65 or younger individual with qualifying disability.

Resources: No limit. Income: No limit.
