# The Benedict Bulleth Fall 2018

The following is a reprint, in part, of a pamphlet published by the New York State Bar Association in cooperation with the New York City Department for the Aging on the subject for elder New Yorkers.

#### 16. NEW YORK STATE SCHOOL TAX RELIEF PROGRAM (STAR)

Provides an exemption from the school portion of property taxes for owner-occupied primary residences. All New Yorkers who own their own one, two or three-family homes, condominiums, or cooperative apartments, mobile homes or farms are eligible for the STAR tax exemption.

#### **Basic Star Exemption:**

Age: Any age.

Apply: By contacting local assessor's office.

#### Middle Class STAR Exemption: Rebate program

Age: Any age.

Resources: No limit.

*Income*: The rebate will be in varying amounts depending upon the locality and your income. Households with income over \$250,000 are not eligible.

Apply: Online or by mail to the New York State Department of Taxation and Finance.

#### **Enhanced STAR Exemption:**

*Age:* 65 or older. *Resources:* No limit.

*Income:* Annual household income of \$87,860 or less. *Apply:* To your local assessor's office or (518) 474-2982.

## 17. LIFE LINE TELEPHONE SERVICE - Reduces the cost of basic telephone service and connection charges for limited-income persons.

Age: Any age.

*Eligibility:* The Life Line Program is available to income-eligible telephone customers who participate in, or are eligible to participate in, any one or more of the following programs: SSI, HEAP, Food Stamps, Medicaid, Veterans Disability or Surviving Spouse Pension, Family Assistance, Safety Net Assistance. *Apply:* By contacting your local telephone company business office.

#### NON-CASH BENEFIT PROGRAMS

Local Offices for Aging contract with providers who deliver meals for the homebound and meals in senior centers. Many local Offices for the Aging provide senior community service employment programs. Additionally, many local Offices for the Aging provide or contract to provide caregiver respite and expanded in-home services programs, as well as adult day services. Some local Offices for the Aging provide health insurance information and counseling programs. Most local Offices for the Aging operate or fund a retired senior volunteer program (RSVP). You should contact your local Office for the Aging for more information or visit the website for your local Office for the Aging. Usually, this can be found by going to the homepage of the website for the county in which you live.
